DECLARATIONS AND AGREEMENTS

By participating in the SunAnza Low-and Moderate-Income Community Solar, I understand that:

1. Filling out this application does not guarantee participation in the SunAnza Low-and Moderate-Income Community Solar Program, and Anza Electric Cooperative, Inc. has the right to deny my participation in the Program.
2. I am aware that by participating in this Program, I will receive solar credits from a community solar array that is not located on my property to offset a portion of my electricity usage. I understand that a portion of the solar credits may be allocated back into the program on my utility bill and savings will vary. Anza Electric Cooperative, Inc. staff will discuss the crediting structure upon sign up.
3. I understand that my name and contact information may be shared with other organizations that provide relevant home repair, energy efficiency and social services. My full application information may also be shared with relevant program administrators if required by local, state, or federal grant administrators or other funders relevant to the solar project.
4. I must provide all required documents and signatures and may need to fill out additional required forms and legal documents related to the Program throughout the process.
5. Trained volunteers, under the supervision of professionally licensed contractors, will provide labor for the community solar array installation.
6. I grant Anza Electric Cooperative, Inc. permission to access my electricity usage history from my electric utility provider in order to calculate the extent of my solar credit.
7. The community solar array will not provide electricity to my home when the cooperative is not able to supply power (i.e., during a blackout).
8. The community solar array may reduce my electricity bills but will not eliminate them completely.
9. I understand that Anza Electric Cooperative, Inc. will give final approval of my acceptance into the SunAnza Low-and Moderate-Income Community Solar Program, if and when it is accepted by the cooperative, I certify that:
10. I am not in the process of selling my house and/or currently planning on moving from the cooperatives service area.

11. The property listed on this application is my primary residence, and I receive and pay my own electric bill at that address.

Indemnification: To the greatest extent permitted by applicable law, I agree to indemnify, defend, and hold harmless Anza Electric Cooperative, Inc the SunAnza Low-and Moderate-Income Community Solar, its affiliates, subsidiaries, current and future parent companies, officers, managers, directors, agents, and employees from all claims, demands, losses, damages, costs, expenses, and liability (legal, contractual, or otherwise), which arise from or are in any way connected with any: (1) decision, action, or inaction by Anza Electric Cooperative, Inc SunAnza Low-and Moderate-Income Community Solar regarding my participation or non-participation in the SunAnza Low-and Moderate-Income Program; (2) violation of local, state, or federal common law, statute, or regulation, including but not limited to environmental laws or regulations; or (3) strict liability imposed by any common law, statute or regulation; so long as such conduct, violation, or strict liability (as set forth in (1) - (3) above) arises from or is in any way connected with the SunAnza Low-and Moderate-Income Community Solar Program, including my or any third party's performance or failure to perform with respect to the Program, however caused, regardless of any negligence of the Anza Electric Cooperative, Inc SunAnza Low-and Moderate-Income Community Solar, their officers, managers, or employees, excepting only such loss, damage, or liability that is caused by the willful misconduct of Anza Electric Cooperative, Inc SunAnza Low-and Moderate-Income Community Solar, its officers, managers, or employees. Limitation of Liability: Without limiting the foregoing indemnification, Anza Electric Cooperative, Inc SunAnza Low-and Moderate-Income Community Solar shall not be liable to me or any of my respective contractors or subcontractors for any special, incidental, indirect or consequential damages whatsoever, including, without limitation, loss of profits or commitments, whether in contract, warranty, indemnity, tort (including negligence), strict liability or otherwise arising from Anza Electric Cooperative, Inc SunAnza Low-and Moderate-Income Community Solar performance or nonperformance of its obligations as manager of the Program.
